### LEADER is a two-step application process.

**Step 1:** Expression of Interest: The EOI is the first step of a two-step LEADER application process.

Please note this is an Expression of Interest form (EOI) and **NOT an application** form. Fully Completed EOIs will be assessed for eligibility under the Rural Development (LEADER) Programme 2023-2027 and approved by the Limerick LCDC. Following eligibility assessment of your EOI, you will be informed of the outcome. If your project is eligible in principle, you will be invited to make a formal application for funding under Step 2.

**Step 2:** Full Application: You will be invited to engage and participate in the West Limerick Resources LEADER application support activities before completing and returning your Application to West Limerick Resources in line with the requirements and timeframes as set out in each particular LEADER Funding Call and the LEADER Operating Rules.

This Expression of Interest (EOI) Form may be completed by a potential Project Promoter as a precursor to an application form proper for funding under the CAP Strategic Plan 2023 -2027 LEADER Programme. Failure to complete this form in full will result in a delay in dealing with your Expression of Interest and any further processing of any subsequent application arising.

### Completion Guidance notes:

- Please review the relevant Call document and accompanying EOI Handbook which details the types of projects eligible before completing the Expression of Interest Form. If you have any queries, please contact the relevant project officer prior to submitting your EOI.
- A separate Expression of Interest Form must be completing for each project for which your group/organisation intends to apply.
- The Expression of Interest Form should be completed by a duly authorised person who is agreed as the primary point of contact for the duration of the application process.
